# Plant of the Month

Golden Bean (*Thermopsis rhombifolia*) By Laura Reeves

Golden bean is known for its brilliant yellow flowers that often blanket entire hillsides in spring (mid-May to June). This 15-50cm tall perennial produces new shoots from rhizomes every year. Stems appear in pairs, with dark green leaves comprised of three leaflets, 2-3 cm long. The leaves have a distinct reticulate veining pattern. Bright yellow pea-like flowers form in clusters at the tips of the stems and later develop into flat, curved, hairy pods about 5cm long. They contain 4-6 seeds. This species may be confused with the exotic bird's-foot trefoil (*Lotus corniculatus*), which has much smaller flowers and leaves and blooms in July. The botanical name, *Thermopsis rhombifolia*, is derived from the Greek words, "thermos" (lupine) and "opsis" (resemblance), referring to the shape of the flowers. "Rhombifolia" refers to the diamond-shaped (rhombic) leaves. This plant is also called "buffalo bean" because Native people used the blooming period as an indicator of when bison bulls were ready for the spring hunt.

This species prefers open, sandy habitats where the water table is high. Though its status is deemed secure in both Alberta and Saskatchewan, it is ranked S2 (imperiled) in Manitoba. Until 2007, golden bean had only bean recorded from the southwestern corner of Manitoba. According to information received from the Manitoba Conservation Data Centre (Wildlife and Ecosystem Protection Branch, Manitoba Conservation), golden bean was previously recorded as far north as Gilbert Plains (on the north side of Riding Mountain National Park) and as far east as Aweme (near Shilo). Most of the records are one-time sightings, and many date back more than 40 years. In 2007, I discovered a population of golden bean at Sandilands – along Hwy. 404 and Bedford Ridge Road – far removed from any other known populations. This anomaly has sparked questions about the origin of the plants and the potential for other populations in the area. According to Alberta Plant Watch, this prairie species has been spreading northward into sandy parkland areas along railway embankments and roadsides.

NOCI member, Richard Reeves, recalls acres of undisturbed prairie, yellow with "buffalo beans", while growing up near Yorkton, SK. He also recalls strict warnings from his mother to steer clear of these poisonous plants. Golden bean contains toxic quinolizidine alkaloids, which are most concentrated in the seeds. Symptoms of poisoning from ingestion of flowers and seeds may include vomiting, dizziness, abdominal pain, drowsiness, nausea, headache, oral irritation, tachycardia, tremors, and other general signs, with severity depending on the amount and plant part ingested. Symptoms generally occur within 3 hours of ingestion and don't last more than 12 hours. Children are most likely to be affected, though golden bean has been suspected in livestock deaths. Native uses of this plant include burning and inhaling smoke from the dried leaves for headaches and colds. The flowers were also used to dye arrow shafts and skin bags.

## **Proposed Amendments to the Bylaws of NOCI**

The following are proposed amendments to our current Bylaws that were adopted by the members at the AGM in 2003 and which can be read at www.nativeorchid.org/bylaws2003.htm.

In 11.2, replace "Secretary" with "Membership-chair", replace "each member" with "each voting member in good standing", so that 11.2 becomes:

11.2 The Membership-chair shall attempt in good faith to send notice to each voting member in good standing at the last known address of the member; however, the absence of notice to any such member shall not invalidate the meeting nor any business conducted thereat.

In 15.3, replace "7" with "9", so that 15.3 becomes:

15.3 The Board of Directors shall consist of 9 members until such a time as the number of Directors is changed in accordance with these Bylaws.

In 16, replace "a Nominating Committee consisting of at least 2 members" with "a member in good standing to be the Nominating-Committee-chair", replace "Secretary" with "newsletter-editor", and add 2 sentences to the end, so that 16 becomes:

16. At least 2 months prior to the election, the Board shall appoint a member in good standing to be the Nominating-Committee-chair whose duty it is to seek candidates to be elected to the Board at the annual meeting. The slate of candidates must be received by the newsletter-editor before the deadline of the last newsletter before the Annual General Meeting. The list of candidates and their biographies will appear in the newsletter and be circulated to the members before the Annual General Meeting. Nominations may also be accepted from the floor. Prior to the election at least one other member in good standing shall be appointed to serve on the Nominating Committee. Someone who is a candidate is not permitted to serve on the Nominating Committee.

In 17.1, replace "The other 3" with "The other 5", so that 17.1 becomes:

17.1 The Nominating Committee shall conduct the elections by secret ballot. The Directors shall be elected by secret ballot at the Annual General Meeting. Four of the Directors will be elected for a 2-year term at a meeting occurring in an even-numbered year. The other 5 will be elected for a 2-year term in an odd-numbered year. Members shall be eligible for re-election to the Board.

In 19.1, add "Membership-chair", so that 19.1 becomes:

19.1 The Executive of the Board shall consist of the following officers: President, Vice-President, Secretary, Treasurer, Membership-chair.

In 20.3, duties of Secretary, in point (b) remove "General Membership", remove "Executive", so that 20.3-(b) becomes:

(b) shall give adequate notice to each Director of each Board Meeting;

In 20.3, duties of Secretary, add the following as point (d):

(d) shall maintain the contact-info for directors, and shall circulate it to all directors whenever it changes.

Add the following as 20.5 to describe the duties of Membership-chair:

20.5 Membership-chair:

(a) shall maintain the membership-list, including for each member a mailing-address, as well as an email-address and telephone-number if provided;

(b) shall produce the mailing-list and emailing-list of members who are in good standing, for each newsletter, and for each meeting of members as described in article-11;

(c) shall periodically make the membership-list available to other directors in both printed and electronic form;

(d) shall determine whether quorum has been met at a meeting of members.

Throughout articles 4, 10.2, 12, (but not 6), replace "fee" or "fees" with "dues", so that the former "membership fees" are now called "membership dues" (but "fieldtrip fees" remain unchanged).

In 4.09, replace "membership chair" with "Membership-chair".

Throughout remove the hyphen in "by-law", "by-laws", "By-Laws", so that these words become "bylaw", "bylaws", Bylaws".

# **Information on Candidates**
